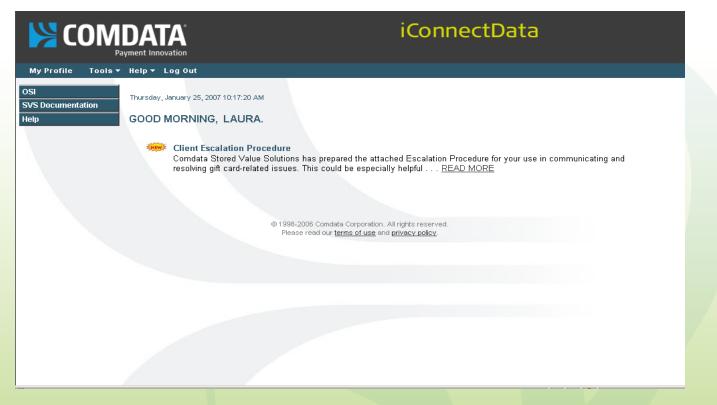

### Accessing iConnectData

#### Logging In

In your web browser address field, type www.iconnectdata.com and press <Enter> (or click the Go button) to display the login screen.

#### Search

The search functionality allows you to search reports based on report type, date and report name as well as client code and division, when applicable. You can access up to 14 months worth of report history using the date ranges in the drop down boxes.

### **General Ledger/Transaction Summary Report**

The Daily General Ledger (G/L) report states the beginning ledger balance, calculates the business day transactions, and then reports the ending ledger balance for the BIN range. All gift card transactions that were performed appear on the G/L Report. At the beginning of each month, SVS clients also receive a monthly G/L report. The monthly G/L Report is based on the previous month's transactions. This report states the ledger balance at the beginning of the month, summarizes the transactions performed during that month, and then reports the ending ledger balance for the BIN range.

To ensure that we have all of the business day transactions for all time zones, we use the Point-of-Sale (POS) transaction date and timestamp, and run the RPT580 reports for transactions that occurred two days prior to the run date. For example, if a POS transaction occurred on Monday, July 5, it will appear on the reports on Wednesday, July 7.

Note: The terms "BIN range" and "client codes" are interchangeable. A client code is assigned to each BIN range by SVS. The client code is displayed in the following report samples.

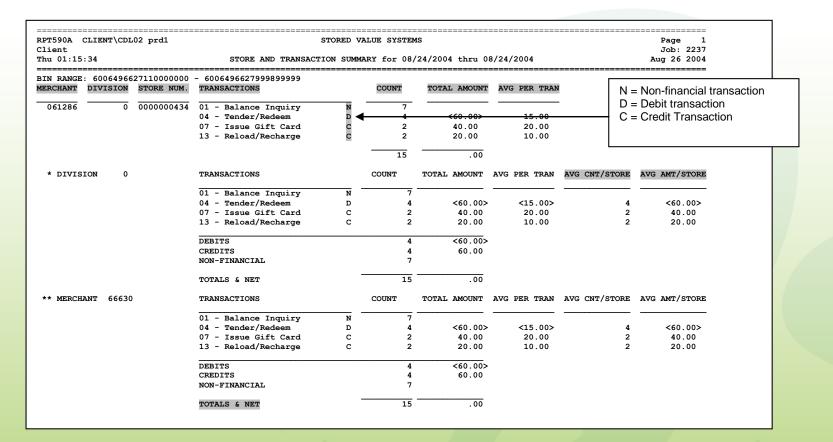
